



2018 January to June Commercial Liming Materials Tonnage Submission Instructions

Please Read the Instructions BEFORE Completing the January – June 2018 Tonnage

A Completed Tonnage Form Per Firm Must be Submitted, **even if No Sales are Being Reported**

Late Fee

On September 1, 2017 a late fee of \$10 or 10% of the total tonnage tax owed, whichever is greater, will be applied. The late fee will increase on the first of every month that the tonnage form is not submitted. A lien will be placed against the registration for the amount owed, including surcharges.

How to Complete the Tonnage Form by Section

Please use the fillable form feature and type the information onto the tonnage form per firm. **Do not combine firms onto one form.**

Company/Firm Information

Do not enter outside registrant information in this section.

- Exact information that is on the product label.
- If you do not use a **Registrant** (see definition below) please put all contact and mailing information in this section **only**.

Registrant Information

- Company/Person other than the company listed on the product label that is responsible for submitting registration
- **Proof of Registration will be mailed to the Registrant mailing address if this section is filled out.**

Product List

EACH product that was registered for July 1, 2017- June 30, 2018 MUST be listed.

- Product name MUST match the product name on the registration form
- CaO%, MgO%, and Type of Lime: List if applicable
- County Code: **3** = New Castle, **1** = Kent, **5** = Sussex
- Form: **Bag, Bulk, Liquid**
- Use: **F** = Farm, **NF** = Non-Farm, **G** = Golf Course, **L** = Lawn
- Total Pounds: List if under 1 ton
- Total Tons: List once the distribution amount reaches 1 ton

Please use the fillable PDF feature and type in all needed Tonnage information.

If the instructions are not followed the tonnage submission may be denied and sent back and a hold placed on your 2019 Registration.

Inspection Fees

- \$0.05 a Ton
 - You do not pay the \$0.05 fee until the total distributed reaches 1 ton(\$0.05)
- The total due will be calculated automatically – *all fees must be paid no matter the dollar amount*
