ORDER OF FINISH – “6-4-1-3” Starters-9

SEVENTH RACE–POST TIME – 4:16 p.m. OFF TIME – 4:18 p.m.

#1, “Child’s Play” and #10, “Patriotic Endeavor” were vet scratches. #7, “I Dream of Lois” was a trainer scratch. **Inquiry concerning the run nearing the wire.** The rider of #8, “Zeven” lodged an **objection** against the rider of #6, “Justa Scoch” for alleged interference in deep stretch. After speaking with the jockeys involved and reviewing the video evidence, the Stewards saw no reason for a disqualification. #8, “Zeven” was claimed by Wasabi Ventures Stables LLC – Jesus Cruz. #11, “Ten Penny Princess” pulled up lame on the far turn and was vanned off.
