Per request of paddock judge & riders; due to the heat, extra 2 minutes in the paddock granted. Good start for all; no incidents to report. Rider #3 Victor Rosales pulled up short; didn't gallop out after the wire.

EIGHTH RACE –POST TIME – 4:57 p.m. OFF TIME – 5:00 p.m. Mutuels +1 minutes #1 fractious in the gate. Good start for all, #1 eased to the wire; rider interview suggested injury in the gate when she broke through. Consultation afterward with DTRC Vet S. Botts. Placed on the vet list for observation.
