**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes**  
#4 is a PV scratch (injury) Dr. Warren. Program correction #6 make the rider Olaf Hernandez (DJM). Voided claim #1 Charging Lion, Proud Stables Inc. owner/trainer Bruno Tessore.  
**ORDER OF FINISH – “1-5-2-3” Starters -5, Time of Race: 1:41.2 (1Mile)**

**SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:47 p.m. Mutuels +1 minutes**  
Outrider(s) mistakenly arrived early for the load, resulting in the loss of that request. #1A is a steward scratch (POE), #4 is a PV scratch (respiratory) Dr. Hawk, #5 is a PV scratch (respiratory) Dr. Good. Program correction #2 the owner is Team Gaudet & Samuel D. Freeman, No Show, Trifecta and/or Superfecta wagering due to diminished field size. #2 claimed by Super C Racing Inc owner/trainer Jamie Ness all-inclusive testing, #3 claimed by KCMH Racing LLC owner/trainer Bernard Dunham all-inclusive testing.  
**ORDER OF FINISH – “2-3-6-1” Starters -4, Time of Race 1:11.3 (6 Furlongs)**

**THIRD RACE – POST TIME – 2:18 p.m. OFF TIME – 2:20 p.m. Mutuels +2 minutes**  
Program correction, rider of #1 is Juan C. Rodriguez (mistake at entry). #2 late to post parade due to change of equipment in paddock. Good start for all, no incidents to report.  
**ORDER OF FINISH – “8-4-2-6” Starters -8, Time of Race 1:13.1 (6 Furlongs)**

**FOURTH RACE – POST TIME – 2:50 p.m. OFF TIME – 2:52 p.m. Mutuels +1 minute**  
#1 selected for blood gas testing, #2 is a PV scratch (viral infection) Dr. Hunt. Program correction, #1 make the rider Carol Cedeno (illness), #3 the owner is Sydenham Racing Stable, #6 is a FTG. #4 inconsistent throughout, per rider was forced to use the crop to engage, #7 was vanned off after the wire; consistently trailed. Should have been pulled up @ the ¼ pole. Upon visitation with the rider after the race, he felt it unsafe/unable to stop.  
**ORDER OF FINISH – “6-3-5-4” Starters -6, Time of Race 1:12.0 (6 Furlongs)**

**FIFTH RACE– Turf - POST TIME – 3:22 p.m. OFF TIME – 3:25 p.m.** Mutuels +2 minutes #1 is selected for blood gas testing. Program correction, #5 make the rider Keiber Coa, (no-show) on a stake elsewhere. #7 claimed by Gendrachi Racing Stable owner/trainer Anthony Pecoraro no test required.

**ORDER OF FINISH – “6-1-2-5” Starters -7, Time of Race 57.3 (5 Furlongs Turf)**

**SIXTH RACE –POST TIME – 3:55 p.m. OFF TIME – 3:56 p.m.** Mutuels +1 minutes #1A is a steward scratch (POE), #6 is selected for blood gas testing. Good start for all, however the rider of the #2 that finished third (3<sup>rd</sup>) was cautioned for standing before the wire.

**ORDER OF FINISH – “1-3-2-6” Starters –6, Time of Race 1:42.0 (1 Mile 70 Yards)**

**SEVENTH RACE – Turf - POST TIME – 4:27 p.m. OFF TIME – 4:30 p.m.** Mutuels +2 minutes. #1 selected for blood gas testing. Stewards Inquiry in the stretch, + two (2) rider objections, #8 on #2 and #1 on #2 in the stretch; both allowed. #2 Capucine was DQ'd from first (1<sup>st</sup>) and placed fourth (4<sup>th</sup>) for interference in the stretch. Riders of #1,#2,#4 and #8 made the film list for Monday, 6/3/19. Jockey Juan C. Rodriguez given 7 calendar days for careless riding as a result.

**ORDER OF FINISH – “4-8-1-2” Starters –8, Time of Race 1:43.0 (1 Mile 70 Yards Turf)**

**EIGHTH RACE –POST TIME – 5:02 p.m. OFF TIME – 5:04 p.m.** Mutuels +1 minutes #2 selected for blood gas testing. #6 is a PV scratch (off-feed/medicated) Dr. Sakuda. Program correction, make the rider of #3 Robert Paz (no-show) riding a stake elsewhere. #5 stumbled hard at the break; corrected quickly. Steward inquiry. #3 erratic in the stretch, made contact with #1 and #5. No Change due to both horses finished ahead of #3. Rider made the film list for Monday.
