Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results. Reviewed/approved license applications prior to 1st post. Film review @ 12:00 with jockeys from previous race day.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes

Program correction; #6, owner should read: Bruno Tessore and Happy Thoroughbred LLC.
Good start for all; no incidents to report.

ORDER OF FINISH – “5-4-6-3” Starters -6, Time of Race: 1:45.2 (1 Mile 70 Yards)

SECOND RACE – POST TIME – 1:49 p.m. OFF TIME – 1:51 p.m. Mutuels +2 minutes

#4 selected for blood gas testing. Program correction; #4 change of rider from Antonio Lopez (no call given to trainer) to Joe Schneider. Claim #2 R True Sensation by MATA Stables owner/trainer Jose S. Rodriguez (steroid test only) **\$6,250.00**

ORDER OF FINISH – “7-3-5-2” Starters –7, Time of Race 1:06.0 (5 ½ Furlongs)

THIRD RACE – POST TIME – 2:22 p.m. OFF TIME – 2:24 p.m. Mutuels +2 minutes

#7 is a PV scratch (respiratory) Dr. Hawk. Program correction; #4 is a first time gelding (FTG), #6 change of rider from Felix Pinero (no call given to trainer) to Jose Calderon.

ORDER OF FINISH – “5-1-6-3” Starters -6, Time of Race 1:07.2 (5 1/2 Furlongs)

FOURTH RACE – POST TIME – 2:54 p.m. OFF TIME – 2:56 p.m. Mutuels +2 minutes

#2 wearing full-cup blinkers on the walk-up to the paddock was erratic and required a pony. Good start for all; no incidents to report. Claim #2 Indian Gulch by Robert D. Bone owner/trainer Victor Carrasco Jr. (no test) **\$16,000.00**

ORDER OF FINISH – “5-2-1-4” Starters -6, Time of Race 1:43.1 (1 Mile 70 Yards)

FIFTH RACE–Turf Race-POST TIME – 3:26 p.m. OFF TIME – 3:29 p.m. Mutuels+2 minutes

#1 selected for blood gas testing. #6 is a steward scratch (medication error after entry per trainer) Delay out of paddock due to fractious horse, #2 in saddling. #7 fractious in the gate, broke thru the gate but was held by the assistant starter; reloaded. **Steward Inquiry; Rider Objection #2**

(FIFTH RACE – Continued) on #7 away from the gate, before the first turn, #7 dropped in, pressuring #3 and #2 slightly, corrected. (Disallowed) Film list for all riders on Monday.

ORDER OF FINISH – “7-3-2-5” Starters -6, Time of Race 1:42.1 (ABT 1 1/16 Miles Turf)

SIXTH RACE-POST TIME – 3:57 p.m. OFF TIME – 4:00 p.m. Mutuels +2 minutes

#4 selected for blood gas testing. Program correction; #3 change of rider from Felix A. Pinero (no call given to trainer) to Jenn Miller. #7 late out, trouble in the paddock. #7 distanced significantly in this effort. Trainer consultation will be forthcoming, steward list probable.

ORDER OF FINISH – “1-6-5-3” Starters -7, Time of Race 1:08.4 (5 1/2 Furlongs)

SEVENTH RACE-Turf Race-POST TIME – 4:31 p.m. OFF TIME – 4:34 p.m. Mutuels +2

minutes. #7 selected for blood gas testing. Program correction; #1 change of rider from Antonio Lopez (no call given to trainer) to Ricardo Chiappe, #2 change of rider from Edwin Gonzalez (no-call) to Keiber Coa. #3 raced with no front shoes which was approved by Dir of Racing John Mooney. (finished 5th) #4 Scrapple a nine (9) year old gelding had to be loaded from the front; backed in. According to Equibase chart, “Scrapple lost contact with the field early and galloped along far behind”. Trainer consultation will be forthcoming, steward list probable.

ORDER OF FINISH – “5-2-1-6” Starters -8, Time of Race 57.3 (5 Furlongs Turf)

EIGHTH RACE –POST TIME – 5:04 p.m. OFF TIME – 5:06 p.m. Mutuels +2 minutes

#4 selected for blood gas testing. #3 is a PV scratch (rhabdomyolysis) Dr. James Fukuda. Program correction; no superfecta wagering due to reduction in field size. This (AR) Allowance Purse \$14,000 after the scratch of #3 was held to 5 betting interests, comprised of three (3) trainers. #6 DAHESSTINY MC with two (2) previous outs in 2018 for a tag of Mcl 25000 and Mcl 10000 “walked under the finish line” per Equibase chart. The stretch call was behind 39 1/2 lengths and the margin was too great for the finish to be annotated. Rider Ricardo Chiappe was told by the Board of Stewards, when a horse offers to walk to dismount and wait for a ride back to the unsaddling area. Mr. Chiappe has been notified to appear for “films” on Monday, June 10th @ 12:00 noon.

Trainer consultation will be forthcoming, steward list probable.
