Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test selection.

**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Mutuels +1 minutes**  
#3 selected for blood gas testing. #2 and #4 are steward scratches (off track/old injury) Program correction, no show, trifecta or superfecta wagering due to diminished field size.

Steward Inquiry; Rider objection #6 on #3 in the stretch. #3 impeded/intimidated #6 beginning at the ¼ pole, hitting #6 with his crop, twice. After review, #3 is DQ'd from first (1<sup>st</sup>) and placed second (2<sup>nd</sup>) for interference. #1 claim is voided due to failure to fill-out claim card correctly. #3 claimed by Princess K Racing owner/trainer Michael L. Catalano Jr. (all-inclusive testing)

**ORDER OF FINISH – “3-6-1-5” Starters -4, Time of Race: 1:11.3 (6 Furlongs)**

**SECOND RACE – POST TIME – 1:46 p.m. OFF TIME – 1:48 p.m. Mutuels + 1 minutes**  
#1 selected for blood gas testing. Good start for all. No incidents to report.

**ORDER OF FINISH – “6-4-1-3” Starters -6, Time of Race 1:13.2 (6 Furlongs)**

**THIRD RACE – POST TIME – 2:16 p.m. OFF TIME – 2:18 p.m. Mutuels +1 minutes**  
#1 was selected for a blood gas testing, #4, #5, #6, #7, #10, #11, #12 and #13 are steward scratches (Off-Turf) Good start for all, no incidents to report.

**ORDER OF FINISH – “8-2-3-1” Starters -5, Time of Race 1:45.0**

**FOURTH RACE – POST TIME – 2:46 p.m. OFF TIME – 2:48 p.m. Mutuels +1 minutes**  
#4 selected for blood gas testing, #5 is a steward scratch (off-track). Good start for all; no incidents.

**ORDER OF FINISH – “6-4-7-1” Starters -6, Time of Race 1:11.3 (6 Furlongs)**

**FIFTH RACE–POST TIME – 3:16 p.m. OFF TIME – 3:18 p.m. Mutuels +1 minutes**  
#2 and #5 are steward scratches (off-turf), #10 is a CV scratch (choking in Lasix barn) Dr. Gilliam. Program correction, #1 change of rider from Vince Halliday to Raul Mena (POE). #6 is selected for “special” testing, beat one (1) horse.

**ORDER OF FINISH – “9-3-7-1” Starters -7, Time of Race 58.4 (5 Furlongs)**

**SIXTH RACE –POST TIME – 3:46 p.m. OFF TIME – 3:47 p.m.** Mutuels +1 minutes  
#1, #1A, #2, and #5 are steward scratches (off-track/ old injuries) Program correction; no show, place exacta, trifecta or superfecta wagering due to reduction in field size. **Win Only Wagering**  
#4 and #6 brushed slightly, out of the turn at the top of the stretch. #6 broke down @ the 1/16<sup>th</sup> pole; losing the rider. Jockey Tyler Connor walked off the track under medical personnel supervision and escorted to first-aid for observation. Notified later by Jock room physical trainer of clearance to return to the saddle. #6 Well Graced (DNF) was humanely euthanized on the track.

**ORDER OF FINISH – “4-3” Starters –3, Time of Race 1:12.1 (6 Furlongs)**

**SEVENTH RACE – POST TIME – 4:16 p.m. OFF TIME – 4:18 p.m.** Mutuels +1 minutes  
#1 is a PV scratch (respiratory) Dr. Migliacci. #1A, #5, #7 and #10 are steward scratches (off-turf). #9. Rider, Raul Mena misused his crop down the stretch. Instructed to attend films on Saturday, 06/15/19 @ 12:00 noon.

**ORDER OF FINISH – “2-9-6-8” Starters –6- Time of Race 1:41.4 (1 Mile)**

**EIGHTH RACE –POST TIME – 4:48 p.m. OFF TIME – 4:49 p.m.** Mutuels +1 minutes  
#1 is a steward scratch (POE) Program correction, no superfecta wagering due to reduced field size. Good start for all; no incidents to report.

**ORDER OF FINISH – “5-2-1A-6” Starters – 6 Time of Race 1:52.1 (1 Mile)**
