Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test selection. Telephonic conversation with Alan Pincus, re: Powell hearing notice. Dealt with a licensee's refusal to submit a urine test for licensure. Summarily suspended this applicant for failure to provide, ruling to follow.

#1 is a steward scratch (POE). **Steward Inquiry:** #6 hopped at the start, no change.

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:49 p.m. Mutuels + 3 minutes
#2 selected for blood gas testing. #5 is a LCV scratch (lame in post parade) Good start for all.
ORDER OF FINISH – “4-2-3-6” Starters –5, Time of Race 1:11.2 (6 Furlongs)

THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:19 p.m. Mutuels +1 minutes
#1 selected for blood gas testing, #4 and #5 are steward scratches (off-turf). #2 is claimed by Tim F. Ritchey Racing Stables Inc. owner/trainer Timothy Richey (no-test)
ORDER OF FINISH – “3-2-7-6” Starters -6, Time of Race 58.2 (5 Furlongs)

FOURTH RACE – POST TIME – 2:47 p.m. OFF TIME – 3:28 p.m. Mutuels +1 minutes
#1 is a steward scratch (POE). #1A broke thru the gate; lost rider and was loose on the track. As a result, #1A was a late steward scratch. There was a 40 minute rain delay, the track was changed to sloppy/sealed. Horses were returned to the paddock as a result. Field was returned to the gate direct from paddock w/o parade. #4 is tardy leaving the gate.
ORDER OF FINISH – “2-5-4-3” Starters -4, Time of Race 59.1 (5 Furlongs)

FIFTH RACE–POST TIME – 3:56 p.m. OFF TIME – 3:57 p.m. Mutuels +1 minutes
#2 selected for blood gas testing. #1 is a steward scratch (POE), #4, #5 and #6 are steward scratches (off-turf). Program correction, no show, trifecta or superfecta wagering due to reduction in field size.

#1 is a PV scratch (respiratory) Dr. Hawk, #5 is a late steward scratch (off-track/old injury)
