Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Extensive discussion with regard to race 6, #6 & #7 are same owner/trainer interests and should be coupled per DTRC rule 11.4.1. **#7 is a mutuel scratch and will run for purse money only.** Safety Steward Eric Coatrieux walked the turf course at the request of riders Alex Cintron, Carol Cedeno and others to verify track safety. Mutually agreed, that the course met the safety & welfare standards established at Delaware Park.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels- +1 minutes.

#4 is selected for blood gas testing. Good start for all.

ORDER OF FINISH – “4-5-1-2” Starters 6, Time: 1:06.2 (5 1/2 Furlongs)

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:49 p.m. Mutuels +1 minutes

#1 is a late steward scratch (off-track), #5 is a late CV scratch (failed to warm-up properly). Program correction, #4 change of rider to Raul Mena from Vince Halliday (suspended). #3 was fractious in the gate.

#7 is selected for blood gas testing. #4 is a late steward scratch (off-turf), #5 is a late steward scratch (off-turf), #8 & #9 are late steward scratches (off-turf). Jockey #7 does not have his physical with him; ordered to fax a copy in the A.M., or face disciplinary action.

FOURTH RACE – POST TIME – 2:45 p.m. OFF TIME -2:52 p.m. Mutuels +1 minutes.

#6 is selected for blood gas testing. Program correction, #1 is ridden by Ricardo Chiappe (POE), #2 change of rider to Jose Garcia from Weston Hamilton (no show). Delay, #2 lost a shoe in the paddock, required re-tacking. Program correction, #3 Self Start will race without front shoes.

Program correction, #9 change of rider from Wilmer A. Garcia to Navin Mangalee (DJM waived).
