Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Discussed the ongoing problem of late program corrections with regard to rider changes. The enforcement of both the house rule and DTRC Rule 8.9.1 specifically about the naming of riders at time of entry, continues to go unresolved.

**FIRST RACE–Turf Race-POST TIME – 1:15 p.m. OFF TIME – 1:18 p.m.** Mutuels- +2 minutes. #3 is selected for blood gas testing. #1 and #1A are both steward scratches (POE), #6 is a PV scratch (colic) Dr. A. Warren. Good start for all, no incidents to report. #6 is claimed by Brittlyn Stables Inc. owner/trainer Jose Camejo. **25,000.00** (no test)

**ORDER OF FINISH – “8-3-7-2” Starters 6, Time: 1:30.4 (7 1/2 Furlongs Turf)**

**SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:49 p.m.** Mutuels +1 minutes #3 is selected for blood gas testing. Riders of #3 & #7 had some difficulties with their respective mounts. #3 was never a factor, #7 eased in the stretch.

**THIRD RACE-Turf- POST TIME – 2:17 p.m. OFF TIME – 2:20 p.m.** Mutuels +2 minutes #5 is selected for blood gas testing. #4 is a PV scratch (respiratory) Dr. Lurito, #6 was a late CV scratch (prerace on the track) Dr. Gillam, #7 is a steward scratch (isolation concerns), #10 is a steward scratch (MTO). Program correction, #6 prior to the late scratch was to be ridden by Alex Cintron to replace J D Acosta (no show, riding in PA).

Steward inquiry; rider objections, #3, #6 on #4 in the stretch; allowed. #4 is disqualified from first (1<sup>st</sup>) and placed third (3<sup>rd</sup>) for interference. Film list on Wednesday.

**EIGHTH RACE-POST TIME – 5:08 p.m. OFF TIME – 5:11 p.m.** Mutuels +2 minutes.  
 #2 is selected for blood gas testing. #7 is a CV scratch (lame on prerace) Dr. Gillam. #4 is claimed by Mata Stables owner/trainer Abel Castellano (no test). Program correction, #3 will race with blinkers (racing office/trainer error at entry)
