Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Met with Dr. Johnson for follow-up, and reached a penalty decision for a DTRC licensee in violation of DTRC rules. Presiding Steward Frederick Burkhardt was feeling ill and was capably replaced by Eric Coatrieux in his absence.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:19 p.m. Mutuels- +1 minutes.
#6 is selected for blood gas testing. #1 is a PV scratch (respiratory) Dr. Johnson, Program correction, no superfecta wagering due to reduced field size. #2 fractious in the paddock; rider bailed resulting a loose horse. #3 loose behind the gate, #4 slow away. #3, possible steward list.

#2 is selected for blood gas testing. #6 is a PV scratch (respiratory) Dr. Johnson.

THIRD RACE- POST TIME – 2:17 p.m. OFF TIME – 2:19 p.m. Mutuels +1 minutes
#6 is selected for blood gas testing. #2 stumbled, #3 bore out at the start, #4 stumbled and was tardy away.

FOURTH RACE -Turf– POST TIME – 2:49 p.m. OFF TIME -2:52 p.m. Mutuels + 1 minutes.
#1A is a steward scratch (POE), #6 is a steward scratch (transportation). Program correction, make the rider Keiber Coa (POE), #7 make the rider Brittany Scampton to replace Wilfredo J. Garcia (no-show).

Program correction, #1 make the rider Brittany Scampton to replace Wilfredo J. Garcia (no-show). #3 is claimed by Glen Gaddy owner/trainer Thomas Iannotti IV (no-test)

SIXTH RACE –Turf- POST TIME – 3:49 p.m. OFF TIME –3:54 p.m. Mutuels + 1 minutes
 #1 is a steward scratch (POE), #1A is a PV scratch (rhabdomyolysis) Dr. A Warren, #7 is a steward scratch (transportation), #13 is a steward scratch (MTO). Program correction, #11 make the rider Jomar Garcia to replace Alexis X. Batista (family emergency). Good start for all. #12 was three (3) minutes late for furosemide administration. Trainer of #12, Marvin Richards will be sent a hearing notice as a result.

ORDER OF FINISH – “3-5-2-9” Starters -10, Time: 58.2 (5 Furlongs Turf)

SEVENTH RACE-POST TIME – 4:22 p.m. OFF TIME – 4:24 p.m. Mutuels +1 minutes
 #1 is selected for blood gas testing. #6 is a steward scratch (medication mistake per trainer). Program correction, #1 change of rider to Brian Pedroza from Erick Lopez (no-call), no superfecta wagering due to reduced field size.

ORDER OF FINISH – “2-4-3-5” Starters – 5, Time: 1:11.3 (6 Furlongs)

EIGHTH RACE-POST TIME – 4:50 p.m. OFF TIME – 4:56 p.m. Mutuels +1 minutes.
 #3 is selected for blood gas testing. #2B is a steward scratch (POE), #2 is a late steward scratch. Program correction, **#6 is wearing a Cornell Collar for the 1st time.** #2 RB BLYNG a first time starter was fractious in the paddock. Lost the rider in the paddock (twice) resulting in a medical clearance for Ricardo Chiappe to participate. Walked onto the track w/o the rider necessitating a late steward scratch. ** #6 Sole On Fire, in 4 total lifetime outs thru today, has finished last in all 4 outs by a combined 187.5 lengths warrant placing on the Stewards list for poor performance.*
