#6 is selected for blood gas testing. #3, #4, #7, #9 and #11 are steward scratches (off-turf). #2 is claimed by Jagger Inc. owner/trainer Jamie Ness **25,000** (all-inclusive testing)

**SEVENTH RACE-POST TIME – 4:22 p.m. OFF TIME – 4:23 p.m.** Mutuels +1 minutes  
#1, #2, #4, #5 and #6 are steward scratches (off-turf). Program correction, no place, show, trifecta or superfecta wagering due to reduced field size.

**ORDER OF FINISH – “7-3” Starters – 2, Time: 1:53.1 (6 Furlongs)**

**EIGHTH RACE-POST TIME – 4:51 p.m. OFF TIME – 4:53 p.m.** Mutuels +1 minutes.  
#3 is a PV scratch (respiratory) Dr. Lurito. Steward inquiry; #1 and #6 on the lead at the 3/16<sup>th</sup> pole when the #6 tried to pull up. #6 vanned off, later confirmation of a bowed tendon. (**1<sup>st</sup> time starter**) Program correction, #1 change of rider to Lucas Berticelli (out of country), #1A change of rider to Jomar Ortega (out of country) for Alexis X. Batista.
