Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Discussed the “affidavit” issue with regard to licensing. Specifically the number of licensees that have not fulfilled licensing requirements.

Nine (9) minute tote delay, tote board inoperable. All commands had to be initiated by tote.
#3 is a late CV scratch (lame in post parade) Dr. Brown.

THIRD RACE-Turf- POST TIME – 2:27 p.m. OFF TIME – 2:30 p.m. Mutuels +2 minutes
#7 selected for blood gas testing. Program correction, #3 change of rider to Brian Pedroza from Tais Lyapustina (no call) with a corrected weight of 121 lbs. Steward inquiry; trainer hold #4 on #6; disallowed.

#4 is selected for blood gas testing. #5 is a PV scratch (respiratory) Dr. Johnson. Program correction, #4 change of rider to Martin Solis from Rebecca Grace LaBarre (no call), corrected weight 121 lbs, #6 change of rider to Augusto Marin from Alexis X. Batista (out of country).

SIXTH RACE –Turf- POST TIME – 3:59 p.m. OFF TIME –3:53 p.m. Mutuels + 2 minutes
#5 selected for blood gas testing. Program correction, #3 change of rider from Andrew Wolfsont to Richard Boucher (no call), #5 change of rider from Maicol J. Inirio to J.D. Acosta (no call), #6 change of rider from Brittany Scampton to Juan Rodriguez (no call). #4 broke through the gate at the start, #3 held by assistant starter preventing a fair start. Both horses, #3 and #4 were declared non-starters for wagering purposes. #1 was vanned off after the race; rider dismounted and refused to ride back for unsaddling.

ORDER OF FINISH- “5-6-8-1” Starters- 9, Time: 1:40.2 (1 Mile)

SEVENTH RACE-POST TIME – 4:34 p.m. OFF TIME – 4:35 p.m. Mutuels +1 minutes
#4 is a CV scratch on pre-race (tendon) Dr. Gillam. Program correction, no superfecta wagering due to reduced field size.

ORDER OF FINISH – “5-6-2-3” Starters – 5, Time: 1:13.4 (6 Furlongs)

EIGHTH RACE-POST TIME – 5:03 p.m. OFF TIME – 5:04 p.m. Mutuels +1 minutes.
#6 is selected for blood gas testing. #1A is a steward scratch (POE). Program correction, #2 will race w/o cheek pieces, #4 will not race with Lasix as listed in program.
