Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Interview with a victim that was assaulted with scissors; ruling to follow against the licensee involved. Addressed an issue with two exercise riders regarding the horse path and area leading to the training track. Track Superintendent indicated that he was working on the drainage issue and made the necessary corrections.

Shortened post parade due to heat index. Good start for all, no incidents to report.

#5 selected for blood gas testing. #2 is a steward scratch (isolation concerns), #6 is a PV scratch (respiratory) Dr. Goode. Program correction, #5 is a first time lasix (L1), no show, trifecta or superfecta wagering due to reduced field size.

THIRD RACE-Turf- POST TIME – 2:18 p.m. OFF TIME – 2:21 p.m. Mutuels +2 minute
#2 is selected for blood gas testing. Good start for all; no incidents to report.
ORDER OF FINISH – “4-1-3-2” Starters – 6, Time: 1:32.3 (7 ½ Furlongs Turf)

FOURTH RACE – POST TIME – 2:51 p.m. OFF TIME – 2:49 p.m. Mutuels +1 minute
#3 is a steward scratch (isolation concerns). Program correction, no superfecta wagering due to reduced field size.

FIFTH RACE–Turf- POST TIME – 3:22 p.m. OFF TIME – 3:25 p.m. Mutuels +2 minutes
Program correction, change of rider #2 from Angel S. Arroyo to Alex Cintron (DJM waived)
#2 claimed by Alavicki Farm owner/trainer Gerard Dennison (no test) **\$16,000**

#7 selected for blood gas testing. #5 is a steward scratch (isolation concerns)

ORDER OF FINISH – “7-2-1-6” Starters -7, Time: 1:06.0 (5 1/2 Furlongs)

SEVENTH RACE-Turf-POST TIME – 4:25 p.m. OFF TIME – 4:28 p.m. +1 minutes
#1 selected for blood gas testing. #3 and #7 are steward scratches (isolation concerns). Steward inquiry; #2 lost the rider at the break. #2 stumbled and met #1 in the middle, clipped heels and #2 lost his mount. #3 loose on the track, (DNF)

ORDER OF FINISH – “6-5-8-4” Starters – 6, Time: 1:31.3 (7 ½ Furlongs Turf)

EIGHTH RACE – POST TIME – 4:58 p.m. OFF TIME – 5:01 p.m. +1 minutes
#2 selected for blood gas testing. #1 is a steward scratch (POE), #3 is a steward scratch (old injury/off-track), #7 is a PV scratch (respiratory) Dr. Hawk. #6 trailed throughout, vanned off after the race/lame. Later diagnosed as a bowed tendon. Program correction, no superfecta wagering due to reduced field size.

ORDER OF FINISH- “1A-4-2-2B” Starters-6, Time: 1:42.1 (1 Mile)
