Administrative:

Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Discussion about the ruling narrative(s) for pending adjudications. Film review for Thursday's card.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes.

No corrections or scratches. Spoke with the rider of #3 about his difficulty pulling this 1st time starter up after the race. His response was “she’s tough like that in the morning too”.

ORDER OF FINISH – “2-4-1-5” Starters- 6, Time: 1:12.3 (6 Furlongs)

SECOND RACE – POST TIME – 1:46 p.m. OFF TIME – 1:49 p.m. Mutuels +2 minutes

#6 selected for blood gas testing. #2 is a steward scratch (personnel difficulties), #3 is a steward scratch (transportation). Program correction, #7 change of rider from Jose R. Betancourt to Jose Garcia (no show), no superfecta wagering due to reduced field size. #1A broke thru the gate; lost rider and ran off. #1A is a late steward scratch as a result.

ORDER OF FINISH – “5-1-4-6” Starters – 4, Time: 1:04.1 (5 ½ Furlongs)

- **Rider Keiber J. Coa transported to hospital via first-aid for stitches to his chin in the 2nd race.**

THIRD RACE-Turf- POST TIME – 2:23 p.m. OFF TIME – 2:27 p.m. Mutuels +2 minutes

#2 is selected for blood gas testing. #4 change of rider from Keiber J. Coa to Robert Paz (injury) #5 is a late CV scratch (lame behind the gate) Dr. Botts.

ORDER OF FINISH – “6-7-2-4” Starters – 6, Time: (7 1/2 Furlongs Turf)

FOURTH RACE – POST TIME – 2:56 p.m. OFF TIME – 2:58 p.m. Mutuels + 2 minutes.

#6 is selected for blood gas testing. #1 is a PV scratch (rhabdomyolysis), #2 is a PV scratch (sole-abscess) Dr. Hanf. Program correction, no show, trifecta or superfecta wagering due to reduced field size. Change of rider (Coa) to Raul Mena, due to injury.

ORDER OF FINISH – “4-6-3-5” Starters –6, Time: 1:36.1 (1 Mile Turf)

#8 is selected for blood gas testing. Program correction, #5 change of rider from Jeremy Rose to Robert Paz (no-show), #6 change of rider from Keiber J. Coa to Raul Mena (injury)
ORDER OF FINISH- “8-7-4-3” Starters- 8, Time: 1:30.2 (7 ½ Furlongs Turf)

SIXTH RACE – POST TIME – 3:50 p.m. OFF TIME –3:56 p.m. Mutuels + 2 minutes
#2 is selected for blood gas testing. #1A is a steward scratch (POE). #3 is claimed by Happy Thoroughbreds, LLC owner/trainer Bruno Tessore (EPO test) **6,250**
ORDER OF FINISH- “3-4-2-6” Starters-6, Time: 1:11.3 (6 Furlongs)

SEVENTH RACE-Turf-POST TIME – 4:27 p.m. OFF TIME – 4:30 p.m. Mutuels +2 minutes
#1 change of rider from Jann N. Hernandez to Jhonatan Mendoza (no-show). #3 is a late CV scratch (lame warming up) Dr. Botts.
ORDER OF FINISH – “7-5-2-1” Starters – 6, Time: 1:42.2 (1 Mile 70 Yards Turf)

EIGHTH RACE-POST TIME – 4:59 p.m. OFF TIME – 4:54 p.m. Mutuels +2 minutes
No scratches or program corrections. #1 slow away. #4 is claimed by Happy Thoroughbreds LLC owner/trainer Bruno Tessore (EPO test) **4,000**
