Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Finalized steward ruling(s), interviewed a licensee about possible tampering with an ongoing investigation. Received a telephone call from Gary Katz purportedly representing Jockey Angel Cruz appeal of his suspension. Inquired as to the Stewards opinion for denial of his stay?

Presented a policy to the racing office for expired Coggins & health certificates. Effective Saturday, August 10th any expired vaccinations are subject to a \$100.00 fine. The notice is placed on the overnight and posted in the racing office.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Mutuels +1 minutes.
Program correction, #1 change of rider from John Bisono to Lucas Berticelli (no-show). #2 bore out in the stretch; pressure on #4. #4 finished ahead of #2; no effect to the order of finish.

SECOND RACE – POST TIME – 1:46 p.m. OFF TIME – 1:47 p.m. Mutuels +1 minutes
#5 is selected for blood gas testing. #1 is a PV scratch (rhabdomyolysis) Dr. Hanf. #6 pulled up at the 5/8’s pole. Vanned off, (DNF). Per confirmation with State Vet, LF bilateral sesamoid fracture; euthanized.

THIRD RACE-Turf- POST TIME – 2:17 p.m. OFF TIME – 2:19 p.m. Mutuels +2 minutes
Program correction, #3 change of rider from Jose R. Betancourt to Raul Mena (DJM).
ORDER OF FINISH – “4-3-6-1” Starters – 7, Time: 1:40.3 (1 Mile 70 Yards Turf)

FOURTH RACE – POST TIME – 2:50 p.m. OFF TIME – 2:51 p.m. Mutuels + 1 minutes.
#6 is selected for blood gas testing. #1 is a PV scratch (LF inflammation) Dr. Ben Davids. Program correction, #5 change of rider from Luis A, Rodriguez Castro to Carol Cedeno (no-show). Note: #4 Backyard Fun, full of run in the early going, quickly faded and finished last.

#3 selected for blood gas testing. Program correction, #1 change of rider from John Bisono to Anthony Salgado (no-show).

SIXTH RACE – POST TIME – 3:55 p.m. OFF TIME –3:56 p.m. Mutuels + 1 minutes
#5 is selected for blood gas testing. Good start for all.

SEVENTH RACE-Turf-POST TIME – 4:26 p.m. OFF TIME – 4:28 p.m. Mutuels +2 minutes
#6 is selected for blood gas testing. #4 is a PV scratch (lame) Dr. Warren. Program correction, #3 change of rider from Angel Suarez to Olaf Hernandez (illness). #3 looked to take a bad step in the stretch run, pulled up after the wire; vanned off. ***Suarez will be required a medical release to return**

ORDER OF FINISH – “5-1-7-6” Starters – 6, Time: 1:40.3 (1 Mile 70 Yards Turf)

EIGHTH RACE-POST TIME – 4:57 p.m. OFF TIME – 4:58 p.m. Mutuels +1 minutes
#5 is a PV scratch (sole-abscess) Dr. Hanf, #6 is a steward scratch (would not load to ship, per trainer). Program correction, #10 change of rider from Keiber J. Coa to Vince Halliday (no-show).
