Owner was given 48 hours to take custody prior to further action by the DTRC.

**FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes.**

#4 is selected for blood gas testing. #1 is a PV scratch (rhabdomyolysis) Dr. Warren. Good start for all. #6 the second place finisher was vanned off after the race. No apparent distress. Notified, slight lameness LF.

**ORDER OF FINISH – “2-6-3-5” Starters- 6, Time: 1:12.4 (6 Furlongs)**

**SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:48 p.m. Mutuels +2 minutes**

#1 is selected for blood gas testing. #5 is a PV scratch (respiratory) Dr. Hanf, #6 is a steward scratch (ROR), #8 is a steward scratch (loading injury). Program correction, no superfecta wagering due to reduced field size.

**ORDER OF FINISH – “1-3-4-7” Starters –5, Time: 1:14.0 (6 Furlongs)**

**THIRD RACE- POST TIME – 2:16 p.m. OFF TIME – 2:18 p.m. Mutuels +2 minutes**

#3 is selected for blood gas testing. #1, #4, #5 and #6 are steward scratches (off-turf). Program correction #8 change of rider from Wilfredo J. Garcia to Tyrone Carter (no-show) corrected weight 121 lbs., no superfecta wagering due to reduced field size.

#4 is a PV scratch (respiratory) Dr. Hawk, #6 and #7 are steward scratches (off-turf). Program correction, no superfecta wagering due to reduced field size.

**ORDER OF FINISH- “8-2-3-1” Starters-5, Time: 1:41.0 (1 Mile)**

**SIXTH RACE –POST TIME** – 3:49 p.m. **OFF TIME** –3:51 p.m. Mutuels + 2 minutes  
#3 is selected for blood gas testing. #1 and #3 are steward scratches (old injuries/off-track), #5 is a PV scratch (off-feed) Dr. Hanf. Program correction, no superfecta wagering due to reduced field size.

**ORDER OF FINISH- “6-4-2-7” Starters- 4, Time: 1:03.2 (5 ½ Furlongs)**

**SEVENTH RACE-POST TIME** – 4:19 p.m. **OFF TIME** – 4:22 p.m. Mutuels +2 minutes  
#1 is a steward scratch (off-turf), #5 is a PV scratch (off-feed) Dr Hanf, #8 is a steward scratch (off-turf), #11 and #12 are steward scratches (AE). Program correction, #3 change of rider from Julio Correa to Carol Cedeno (DJM waived), #4 change of rider from Juan C. Rodriguez to Vince Halliday (no-show), #10 change of rider from Wilfredo J. Garcia to Tyrone Carter (no-show) CW 121 lbs. Steward inquiry; rider objection #2 and #7 on the #10 in the stretch. #10 was erratic in the stretch, impeding both #2 and #7. #10 lost the rider after the wire.

**EIGHTH RACE-POST TIME** – 4:58 p.m. **OFF TIME** – 5:00 p.m. Mutuels +2 minutes  
Program correction, #8 change of rider from John Bisono to Ricardo Chiappe (family emergency/excused). Rider objection #8 on #5 in the last furlong; disallowed.
