#1 is selected for blood gas testing. #3 is a PV scratch (inflammation RF) Dr. Warren, #6 is a PV scratch (splint) Dr. Hawk. Program correction, #8 change of equipment (no-hood)

THIRD RACE- POST TIME – 2:16 p.m. OFF TIME – 2:17 p.m. Mutuels +1 minutes
#3 is selected for blood gas testing. Program correction, no superfecta wagering due to reduced field size. #1 was claimed by AG Racing owner/trainer Lucia Garibay (claim voided due to violation of track rules) Pony Person Andrus I. Garibay (AG Racing) was in the paddock for race 3 which violates the aforementioned rule. Also, Paddock Judge Joelyn Rigione notified the Stewards that Jockey Alex Cintron was on a cell phone in the paddock before entrance to the track.
