#3 is selected for blood gas testing. #5 is a steward scratch (medication error). Program correction, change of rider from Mychel J. Sanchez to Angel Suarez (no show), no superfecta wagering due to reduced field size.

#1 is a steward scratch (POE). Good start for all. #8 trailed throughout; placed on the stewards & vet list for poor performance.

**THIRD RACE-Turf- POST TIME – 2:17 p.m. OFF TIME – 2:19 p.m. Mutuels +2 minutes**  
#6 is selected for blood gas testing. #2 is a steward scratch (medication error), #3 is a CV scratch (lame on pre-race), #9 is a steward scratch (missed lasix). Program correction, change of rider from Weston Hamilton to Jose R. Betancourt (no-show).
