#1 claimed by Bell Gable Stable, LLC owner/trainer Scott Lake (all-inclusive) **25,000**. Stewards Inquiry; Jockey objection #5 on #4 & #6 at the break. #5 broke slow, #4 lugged out and took his spot as a result. #6 bore in slightly; corrected quickly. Objection; disallowed, no change.
