#4 is selected for blood gas testing. #2 is a steward scratch (ROR). Good start for all.

SECOND RACE – POST TIME – 1:46 p.m. OFF TIME – 1:48 p.m. Mutuels +2 minutes

#5 is selected for blood gas testing. #1 is a PV scratch (respiratory) Dr. Hanf. Program correction, no superfecta wagering due to reduced field size.

ORDER OF FINISH – “2-6-3-5” Starters – 5, Time: 1:39.1 (1 Mile)

***review notification, racing secretary Tom Creel, contacted the board of stewards after declaring the race official, that the winner #2 was ineligible. This ineligibility was due to a race on 10/09/18 @ Finger Lakes that was a “restricted” stake. We asked him to verify and contact both the owner & trainer for notification. The board of stewards received a call from both parties, (owner & trainer) with their complaints. We advised that no decision would be made about possible DQ’s until further investigation into the matter. We contacted the horsemen’s bookkeeper to put a hold on all purse monies pending that review.**

#1 selected for blood gas testing. #2 is a PV scratch (respiratory) Dr. Johnson. Program correction, #4 change of rider from Sunday Diaz Jr to Tyrone Carter (excused/dehydration). #3 wide in the turn, #1 wide out of the turn in the lane. Film list for both riders on Monday July 29th and both horses will be placed on the Stewards list.
