Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Conference call with AG's office about pending matters. Clearance given on a glaucine positive; purse released. Trainer Juan Bacallao-Vega called after the 1<sup>st</sup> race to inform that ties with owner Jack Cannon had been severed. Horses to remain in his care until the current bill of approximately \$5,000.00 was paid in full. Later notified that owner Cannon wants to transfer to another trainer.

**FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes.**  
#4 is selected for blood gas testing. #2 is a CV scratch (sole-abscess RF). #6 slow away, steward's inquiry. #6 false broke/compromised start, resulting in a delay/inquiry. Could not confirm anything other than the horse caused his own problems. No change to order of finish. Spoke with rider following the race, confirmed our supposition.

**SECOND RACE – POST TIME – 1:48 p.m. OFF TIME – 1:51 p.m. Mutuels +2 minutes**  
#5 selected for blood gas testing. #1 is a PV scratch (respiratory) Dr. Crager. #3 is a steward scratch (entry error). Program correction, no superfecta wagering due to reduced field size.

**ORDER OF FINISH – “7-6-4-2” Starters – 5, Time: 1:06.0 (5 1/2 Furlongs)**

**THIRD RACE-Turf- POST TIME – 2:21 p.m. OFF TIME – 2:24 p.m. Mutuels +2 minutes**  
#1 is a steward scratch (MTO). Steward Inquiry at the top of the stretch, #8 bore in on #2 in the stretch, impeding the #2 and almost clipping heels. #2 lost his mount as a result. #8 is disqualified from fourth (4<sup>th</sup>) and declared unplaced. (#2 DNF) Film list for the rider of #8 on Thursday @ 12:00 noon.

Pino (all-inclusive) **12,500**, #5 is claimed by Jagger Inc. owner/trainer Jamie Ness (all-inclusive)
