Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Held several meetings this morning with licensees in regard to rule violations, disagreements, and complaints. Sent out hearing notices via Investigator Sarah Crane for hearing on Friday, August 30, 2019.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:20 p.m. Mutuels +1 minutes
#5 is selected for blood gas testing. #3 is a late CV scratch on the track (lame/warm-up) Dr. Botts. Delay due to the aforementioned scratch. Good start for all.

ORDER OF FINISH – “4-2-5-6” Starters- 5, Time: 1:10.3 (6 Furlongs)

SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:49 p.m. Mutuels +1 minutes
#3 is selected for blood gas testing. #1 is a PV scratch (respiratory) Dr. Hawk, #5 is a PV scratch (colic) Dr. Lockhard, #6 is a PV scratch (respiratory) Dr. Warren, #7 is a PV scratch (cast) Dr. Warren. Program correction, win wagering only due to reduced field.

ORDER OF FINISH – “3-2-4” Starters –3, Time: 1:41.1 (1 Mile)

THIRD RACE- POST TIME – 2:17 p.m. OFF TIME – 2:18 p.m. Mutuels +1 minutes
#6 is selected for blood gas testing. Rider objection, #1 on #3 and #5 in the first turn. Allowed on #3. #3 dropped in on #1 in the turn, without even looking. Dangerously close to clipping heels. #3 is disqualified from 1st and placed third (3rd) for interference. Film list on Thursday.

#7 is selected for blood gas testing. #1 is a steward scratch (POE), #8 is a late CV scratch (lame; warm-up) Dr. Botts. First time starter/winner for trainer Brittany Eckert and set a new track record on a turf course listed as Good.

ORDER OF FINISH- “4-1A-2-7” Starters- 7, Time: 1:28.1 (ABT. 7 ½ Furlongs Turf)

SIXTH RACE –POST TIME – 3:56 p.m. **OFF TIME** –3:57 p.m. Mutuels + 1 minutes
No changes or program corrections.

#7 is a steward scratch (ROR), #2 is a late CV scratch (mouth hemorrhage). Steward Inquiry; #10 fractious in the gate; threw his head at the break. Caused his own trouble, no change.
