Weather: 83 degrees +/-, Mostly Sunny
Track - Fast Turf – Firm **1:15 post time**

Administrative:

Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Held an informal hearing with a rider summarily suspended last week. This rider was asked to provide a urine sample prior, and passed. With no prior history and this negative test is restored to a conditional good standing status. Is subject to further testing as condition of his licensure.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:18 p.m. Mutuels +1 minutes
#6 is selected for blood gas testing. Program correction, #1 change of rider from Joseph Schneider to Vince Halliday (no-show), #4 change of rider from Trevor McCarthy to J D Acosta (riding @ Colonial). #3 distanced by many, finished last. Per rider, when he changed leads fell apart and afraid to ask for more. Trainer notified after the race by rider.

ORDER OF FINISH – “2-6-1-5” Starters- 6, Time: 1:08.0 (5 1/2 Furlongs)

SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:48 p.m. Mutuels +1 minutes
#1 is selected for blood gas testing. #4 is a LCV scratch (flipped in the paddock) Dr. Calley.

ORDER OF FINISH – “6-1-2-5” Starters –6, Time: 1:43.2 (1 Mile 70 Yards)

THIRD RACE-Turf- POST TIME – 2:17 p.m. OFF TIME – 2:19 p.m. Mutuels +2 minutes
#8 is selected for blood gas testing. Program correction, #2, change of owner to Alberto Astudillo, #4 is Delaware Certified. #7 tardy at the break; corrected, #8 competitive until the 7/8's then distanced. Eased in the stretch, per rider changed leads several times before easing to the wire. Notified trainer following the race that the filly had some discomfort and was trying to protect her.

ORDER OF FINISH – “2-6-3-7” Starters – 9, Time: 1:29.3 (ABT. 7 ½ Furlongs Turf)

FOURTH RACE-POST TIME- 2:50 p.m. OFF TIME- 2:51 p.m. Mutuels + 1 minutes
No changes or corrections. #4 eased in the stretch, per rider, real short in the stretch and was traveling bad. Notified the trainer afterward, called Dr. Calley to question his opinion.

ORDER OF FINISH – “6-1-3-2” Starters 7, Time: 1:40.2 (1 Mile)

FIFTH RACE-Turf-POST TIME –3:21 p.m. **OFF TIME** – 3:22 p.m. Mutuels +2 minutes
Program correction, #7 change of owner to Vince Campanella and Nation’s Racing Stable, LLC.
#1 extremely fractious in the gate, had to load w/o rider. Notified by the starter that the reason was due to the extreme horse fly invasion. Will notify management.

ORDER OF FINISH- “7-3-4-2” Starters- 7, Time: 1:04.2 (5 ½ Furlongs)

SIXTH RACE –POST TIME – 3:52 p.m. **OFF TIME** –3:53 p.m. Mutuels + 1 minutes
#4 is selected for blood gas testing. #7 out last due to an equipment change; subsequently scratched by track veterinarian (LCV) Dr. Gillam for failure to “warm-up” satisfactorily.

ORDER OF FINISH- “2-3-6-4” Starters- 6, Time: 1:39.1 (1 Mile)

SEVENTH RACE-Turf-POST TIME – 4:25 p.m. **OFF TIME** – 4:27 p.m. Mutuels +2 minutes
#11, #12, #13 and #14 (AE’s) are all excluded from participating (no scratches). No changes or corrections. Rider objection #5 on #9 in the stretch; **disallowed**. #1, #5, and #9 in tight at the top of the stretch. #5 tried to go thru a hole that closed before he got there. #1 bore out slightly and created an opening, #9 bore out slightly but the hole had already closed and #5 had no place to go. Customer complaint about the effort of the rider of #10, reviewed, consulted with rider and follow up tomorrow. #10 was claimed by Winning Stables, Inc. owner/trainer Gerald Bennett (no-test) **16,000**

ORDER OF FINISH- “8-9-1-5” Starters- 10, Time: 1:36.4 (ABT. 1 Mile Turf)

EIGHTH RACE-POST TIME – 5:00 p.m. **OFF TIME** – 5:01 p.m. Mutuels +1 minutes
#1 is selected for blood gas testing. #4 is a steward scratch (ROR). Program correction, #1A change of rider from Angel Suarez to Raul Mena (POE), #6 change of rider from Maicol J. Inirio to J D Acosta (no-show).
