Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Called another jurisdiction and spoke with a Steward about entry of a horse scratched here (ROR) today and entered to run tomorrow in MD. Received a call from an owner with regard to a horse scratched on Wednesday. Complaint that the rider took the horse to the Vet and consequently scratched. Spoke with the rider and verified lameness prior to vet scratch. Will reach out to the owner for conveyance of our findings.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Mutuels +2 minutes
#2 is selected for blood gas testing. Program correction, #3 change of rider from Juan C. Rodriguez to Jose Betancourt (illness).

ORDER OF FINISH – “3-4-2-5” Starters- 6, Time: 1:11.3 (6 Furlongs)

SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:49 p.m. Mutuels +2 minutes
#1 is a PV scratch (colic) Dr. Ingersoll. Program correction, change of rider from Juan C. Rodriguez to Jose Betancourt (illness). Good start; DEAD HEAT for third (3rd).

ORDER OF FINISH – “6-5-4-7” Starters –6, Time: 1:12.2 (6 Furlongs)

THIRD RACE- POST TIME – 2:19 p.m. OFF TIME – 2:23 p.m. Mutuels +2 minutes
#5 is selected for blood gas testing. #3 tardy at the break and bore out, causing his own trouble.

ORDER OF FINISH – “6-2-1-3” Starters – 6, Time: 1:29.3 (6 Furlongs)

FOURTH RACE-POST TIME- 2:50 p.m. OFF TIME- 2:51 p.m. Mutuels + 1 minutes
6 is a PV scratch (respiratory) Dr. Bowman. #4 fractious in the paddock; loose in post parade; needs schooling. Rider’s objection, #1 on #3 top of the lane; disallowed. #1 claimed interference on the rail, #3 never altered course, no change.

ORDER OF FINISH – “3-1-2-4” Starters 6, Time: 1:05.2 (5 ½ Furlongs)

FIFTH RACE-Turf-POST TIME –3:24 p.m. **OFF TIME** – 3:26 p.m. Mutuels +2 minutes
#7 is selected for blood gas testing. #6 is a steward scratch (ROR), #8 is a PV scratch (rhabdomyolysis) Dr. Fukuda, #10 is a steward scratch (AE). Program correction, #5 change of rider from Juan C. Rodriguez to Raul Mena (illness).

ORDER OF FINISH- “9-2-3-1” Starters- 7, Time: 58.0 (ABT. 5 Furlongs Turf)

SIXTH RACE –POST TIME – 3:57 p.m. **OFF TIME** –3:59 p.m. Mutuels + 2 minutes
No changes and/or program corrections. Steward’s Inquiry; #7 collapsed at the top of the stretch, lost the rider. Severe EIPH; walked off. Rider taken off her mount in the following race for precautionary reasons. Examined and approved to continue in the eighth (8th).

ORDER OF FINISH- “1-4-5-2” Starters- 7, Time: 57.2 (5 ½ Furlongs)

SEVENTH RACE-Turf-POST TIME – 4:29 p.m. **OFF TIME** – 4:33 p.m. Mutuels +2 minutes
Program correction, #2 is a change of rider from Carol Cedeno to Robert Paz (previous race/spill). Note: Johnathan Horowitz from the Arabian Jockey Club had to be asked to vacate from the outside rail prior to the running of this race. He and 2 others were filming/working prior to the 8th. Contacted him and was not given permission to be there by anyone.

ORDER OF FINISH- “3-1-7-4” Starters-9, Time: 57.2 (ABT. 5 Furlongs)

EIGHTH RACE-Grade 1 Arabian Distaff Handicap.-POST TIME – 5:03 p.m. **OFF TIME** – 5:05 p.m. Mutuels +2 minutes

All participant selected for blood gas testing. #5 is a steward scratch (stake). Program correction, no superfecta wagering due to reduced field size.

ORDER OF FINISH- “2-6-1-4” Starters-5, Time: 2:05.2 (1 1/8 Miles)
