Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Consultation with a pony person with regard to complaints on his horse. Composed a letter of reference for a licensee in Dubai. Addressed a letter that was hand delivered in response to a licensee suspension. Composed and mailed a written response, via regular and certified mail. Twenty two (22) steward scratches this card, 19 of these are “off-turf” scratches.

FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:18 p.m. Mutuels +2 minutes
#4 is selected for blood gas testing. #2 is a PV scratch (colic) Dr. Hanf, #3, #5 and #7 are steward scratches (off-turf). Program correction, #6 change of rider from Juan C. Rodriguez to Ricardo Chiappe (no-show) cw. 124#, no show, trifecta or superfecta wagering due to reduced field size. #4 is slow away at the break; lugged out.

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:47 p.m. Mutuels +2 minutes
Program correction, #2 change of rider from Juan C. Rodriguez to Brian Pedroza (no-show) cw. 121#.

ORDER OF FINISH – “4-3-1-2” Starters –6, Time: 1:38.0 (1 Mile)

THIRD RACE- POST TIME – 2:15 p.m. OFF TIME – 2:17 p.m. Mutuels +2 minutes
#4 is selected for blood gas testing. #2 is a steward scratch, #6 is a steward scratch (off-turf). Program correction, #3 change of rider from Juan C. Rodriguez to Jose Betancourt (no-show) cw. 120#, no show, trifecta or superfecta wagering due to reduced field size.#5 fractious in the gate, #1 finished back; rider says she’s not a main track horse. (prefers the turf) * **Trainer complaint about the #5 being loaded 1st, resulting in “fractious in gate”, after speaking with the starter prior? Talked with the starter about the trainer complaint.**

#5 is selected for blood gas testing. #3 is a PV scratch (rhabdomyolysis) Dr. Warren. Program correction, no superfecta wagering due to reduced field size.

ORDER OF FINISH – “5-4-2-1” Starters 5, Time: 1:45.0 (1 Mile 70 Yards)

FIFTH RACE-POST TIME –3:15 p.m. **OFF TIME –** 3:17 p.m. Mutuels +2 minutes
#’s 1,3,4 and 6 are steward scratches (off-turf), #2 is a steward scratch (missed furosemide; noticed) Program correction, no show, trifecta or superfecta wagering due to reduced field size.

ORDER OF FINISH- “8-5-7” Starters- 3, Time: 1:40.1 (1 Mile)

SIXTH RACE-POST TIME – 3:46 p.m. **OFF TIME –** 3:48 p.m. Mutuels + 2 minutes
Program correction, #1 is a change of rider from Juan C. Rodriguez to Jose Betancourt (no-show)

ORDER OF FINISH- “3-5-4-6” Starters- 6, Time: 1:43.3 (1 Mile 70 Yards)

SEVENTH RACE-POST TIME – 4:17 p.m. **OFF TIME –** 4:19 p.m. Mutuels +2 minutes
#8 is selected for blood gas testing. #’s 1, 1A, 3, 5, 6, 7, 9, 10 and 11 are stewards scratches (off turf), #6 is a steward scratch (ROR) ineligible. #6 is claimed by John Rigatteri O/T (no-test) **8,000**. Program correction, change of rider from Juan C. Rodriguez to Robert Paz cw. 121 lbs. (no-show), win only wagering due to reduced field size.

ORDER OF FINISH- “4-8-2” Starters-3, Time: 1:44.0 (1 Mile 70 Yards)

EIGHTH RACE-POST TIME–4:47 p.m. **OFF TIME –**4:50 p.m. Mutuels +2 minutes
#5 is selected for blood gas testing. #6 is a steward scratch, ineligible. Program correction, change of rider from Jason Nguyen to Robert Paz (no-show).

ORDER OF FINISH- “4-5-3-7” Starters- 6, Time: 1:12.2 (6 Furlongs)
