Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Licensing review with two (2) licensees about their status. Reviewed customer complaints about various procedural questions and resolved those satisfactorily.

**FIRST RACE–POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Mutuels +3 minutes**  
#2 is a PV scratch (temp). Program correction, no superfecta wagering due to reduced field size.  
**ORDER OF FINISH – “1-6-5-3” Starters- 5, Time: 1:12.1 (6 Furlongs)**

**SECOND RACE –Turf- POST TIME – 1:49 p.m. OFF TIME – 1:51 p.m. Mutuels +2 minutes**  
#9 is selected for blood gas testing. # 10-12 are steward scratches (AE). Steward’s Inquiry, #7 broke down @ the 3/16<sup>th</sup> pole, DNF. Rider called following the race complaining about the inconsistency of the surface. #7 was euthanized (RF bilateral condylar fracture w/soft tissue eruption). Euthanized by Dr. Johnson (PV) for Gerald Bennett.  
**ORDER OF FINISH – “6-3-4-1” Starters –9, Time: 1:36.0 (ABT. 1 Mile Turf)**

**THIRD RACE- POST TIME – 2:22 p.m. OFF TIME – 2:23 p.m. Mutuels +1 minutes**  
#6 is selected for blood gas testing. Program correction, #6 change of rider from J.D. Acosta to Alex Cintron (injury) Good start for all.  
**ORDER OF FINISH – “5-4-2-6” Starters – 6, Time: 1:46.4 (1 Mile 70 Yards)**

**FOURTH RACE-Turf-POST TIME- 2:51 p.m. OFF TIME- 2:54p.m. Mutuels + 2 minutes**  
#1 is selected for blood gas testing. Program correction, #1 change of rider from Ruben Silvera to Luis Rivera (no-show), #2 change of rider from Keiber Coa to Martin Solis (excused). #’s 10-13 are steward scratches (AE). #9 lost the rider after the wire, rider called following the race. #8 made a u-turn in front of him galloping out; dropped Chiappe as a result.

**FIFTH RACE-POST TIME –3:24 p.m. OFF TIME – 3:25 p.m. Mutuels +1 minutes**
