Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Held an informal hearing in the matter of “failure to disclose” for a Delaware Park employee. Stewards finding that he is eligible and acceptable to remain licensed. Any omission was a result of his misunderstanding the two (2) application process. Reviewed scratch protocol once again to ensure accuracy prior to distribution. Finalized ruling for distribution for hearing on 09/13/19. Received a telephonic waiver of hearing notice; accepted the penalty and the ruling is finalized.

 #6 is selected for blood gas testing. #3 is a steward scratch (ROR), #10 and #11 are steward
 scratches (AE). Rider’s objection(s), #2 on #5, #6, #7 and #8. #6 on #5 in the first turn. Stewards
 Inquiry. #8 dropped in on the #7, #1 had to check and moved out impeding #'s 2, 4, 5, 6 and #7.
 Rider of #8 never looked back before dropping in. Objection #2; allowed, objection #6 on #5
 disallowed. #8 is disqualified for interference in the first turn; initiating the chain reaction that
 occurred. **Film list for Wednesday, September 18, 2019 (all riders)**

 Stewards list for poor performance.
