Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Met with a trainer for a 10:00 am meeting @ 10:25. Rescheduled the conversation until tomorrow (Friday) due to his not being on time and other business. Telephone service went out prior to the start of today's card, necessitating a slight delay of communication between mutuels, clerk of scales, placing judges, claims, tote, etc. Service returned briefly @ 1:20pm, and failed prior to declaration of the race as "official". That communication was necessary via cell-phone. Service was back-up prior to post time of the second (2nd) race.

Slight delay, (see-above) No other changes or corrections. Good start for all.

#2 is a PV scratch (mastitis) Dr. Hawk. Program correction, #6 change of rider from C.C. Lopez to Deidre Panas (trainer conflict; excused)

#4 is selected for blood gas testing. #1 is a PV scratch (cellulitis) Dr. Hawk, #2 is a PV scratch (gastrointestinal). Program correction, no superfecta wagering due to reduced field size. #6 is claimed by Victor Carrasco Jr. O/T (no-test) **6,250**

#3 is selected for blood gas testing. #9 is a steward scratch (trainer), #11, #12, #13 and #14 are steward scratches (AE). Program correction, #3 change of rider from Joseph Schneider to Vince Halliday (no-show), #8 change of rider from Ricardo Chiappe to Deidre Panas (refusal; excused). #10 stumbled after the wire, lost rider.
