

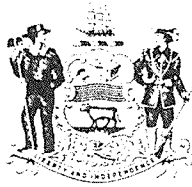

The change in ownership occurred on this date without authorization and/or a bill of sale from the owner and breeder, JD Farms.

After hearing all testimony and evidence presented, the Delaware Park Board of Stewards suspend the occupational license (DTRC 81857) of Gerald James for three hundred and sixty five (365) days, from November 1, 2019 through October 30, 2020. Reinstatement is contingent upon the successful completion of a written and practical trainers test at Delaware Park. During the terms of this suspension, Owner Trainer Gerald J. James is denied access to all facilities under the jurisdiction of the Delaware Racing Commission. All horses owned or trained by Gerald. J. James are denied entry pending sale or transfer to a party approved by the Stewards. 
