Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, selected blood gas test horses. Reinstated a licensee, following a “negative” confirmation of a positive field-test kit result on Friday, June 20, 2019. Listened to an alleged “financial” complaint against a trainer. Referred back to the trainer for payment prior to sending a Stewards hearing notice. Reviewed a race with Tom Foley w/ Jockey’s Guild, from July 31st Race 3. Their complaint alleges that this Board has been too harsh in the penalty process for riding infractions. After the film review, he agreed with the decision by the Board on that call. The Guild proposes a meeting with the Stewards prior to the 2020 meet.
