Hot Walker William G. Day, DOB: 2/05/1991, RCI ID: 2101734, having tested positive for THC, and having been found with drug paraphernalia in the stable area at Delaware Park, is hereby summarily and indefinitely suspended, pending a hearing before the Board of Stewards. Mr. Day is entitled to a hearing on his suspension no later than three (3) racing days from this date. The deadline in asking for an appeal or for waiving his right to a hearing is Wednesday, July 08, 2020. During the time of his suspension, Mr. Day is denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to DTRC Rules: 2.1, 2.5, 3.3, 3.4, 3.4.1.3, 3.4.1.7, 18.1, 18.1.5, 18.1.5.1, 18.1.5.2, and 18.1.5.3.

(AMENDMENT):

After conducting a hearing on July 11, 2020. The summarily suspension of William G. Day was "UPHELD" by the Board of Stewards at Delaware Park.

On July 24,2020 the summarily suspension was 'Lifted'.

On July 17, 2020. Mr. Day was notified of a hearing scheduled on July 24,2020 on the facts of his case. Mr. Day failed to participate.
