Narrative:

Jockey Brian Pedroza DOB: 10/23/1991, RCI ID# 1958961, is suspended Five (5) racing days, August 26,27,29,31 and September 2, 2020, for not making his best effort to control and guide his mount leaving the starting gate during the running of the sixth (6) race on August 17, 2020 at Delaware Park. A violation of D.T.R.C. Rule 14.15 and 14.16. Rule (14.15) If a leading horse or any other horse in a race swerves or is ridden to either side so as to interferes with or intimidates or impedes any other horse, it is a foul. If, in the opinion of the Stewards a foul alters the finish of a race, any offending horse "MAY" be disqualified by the Stewards. Rule (14.16). A Jockey "SHALL" be responsible for making his best effort to control and guide his mount in such a way as not to cause a foul. If in the opinion of the Stewards a Jockey does not make his best effort whether intentionally or through carelessness such a Jockey may be penalized at the discretion of the Stewards.

Jockey Brian Pedroza is suspended five racing days, September 16, 17, 19, 21 and 23, 2020.
