Narrative:

Exercise Rider Anne Gillen, DOB: 10/18/1991, RCI ID: 1780271, having tested positive for THC and Methamphetamine at Delaware Park, is hereby summarily suspended, pending a hearing before the Board of Stewards. Ms. Gillen is entitled to a hearing on her suspension no later than three (3) racing days from this date. The deadline in asking for an appeal or for waiving her right to a hearing is Wednesday, August 12, 2020. During the time of her suspension, Ms. Gillen is denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to DTRC Rules: 2.1, 2.5, 3.3, 3.4, 3.4.1.3, 3.4.1.7, 18.1, 18.1.5, 18.1.5.1, 18.1.5.2, and 18.1.5.3, 21.3.1 All.

1. **On August 12, 2020 the summarily suspension was “LIFTED”.**
2. *Exercise Rider Anne Gillen is suspended 30 days, August 5, 2020 through and including September 3, 2020, for testing positive for Amphetamines, Methamphetamine and THC. A violation of D.T.R.C. Rules 21.3.1, 21.3.1.1, 21.3.1.2, 21.3.1.3, 21.3.1.4, 21.8.2, 21.8.3 and 21.8.5.*
3. *Miss Gillen is denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission.*
4. *Miss Gillen must submit to a professional evaluation by a substance abuse professional approved by the Commission or its designee. Miss Gillen must properly follow the prescribed rehabilitation program and must provide a negative drug test.*

(Amendment):

After fulfilling her obligation of completing a professional evaluation for substance abuse and providing a negative drug test. Exercise Rider Anne Gillen is restored to good standings.
