### **Narrative:**

Owner Mark Brian Esposito, DOB: 01/10/1980, RCI ID: 2020186, after being duly notified and having appeared in a hearing before the Board of Stewards at Delaware Park on May 20, 2021, in the matter of a Financial Complaint. Mr. Esposito then "Waived" his right to counsel in this matter. Stewards reviewed the evidence of the complaint and rendered a decision on the complaint before them. Owner Mark Brian Esposito is "Suspended" until the financial complaint is satisfied. Mr. Esposito is in violation of DTRC Rules 2.4, 2.5.1.4, 2.5.1.22, 3.3 All and 3.4 All. Mr. Esposito failed to comply with an order of the Stewards. Mr. Esposito's actions are not consistent with the best interest of racing and maintenance of the honesty, integrity, and high quality it heretofore has enjoyed in Delaware.

During the term of his suspension, Mark Brian Esposito is denied access to all facilities and grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission.

Horses owned by Mr. Esposito must vacate Delaware Park and are denied entry, pending sale or transfer to a party must be approved by the Board of Stewards.


