Riders on #1 Shahaada (Silvera) and #4 Peace Out (Delgado) did not want to ride they felt that their horses were not acting right and was becoming overheated, the heat index was 99 degrees. Horses were behind the gate for 34 minutes plus 6 minutes of post parade for a total of 40 minutes, out of concern for the safety of the horses being exposed to the heat for that period of time the Stewards Cancelled Race 4.
