After speaking with both riders in this incident Stewards determined that #2 was outside with #8 in the middle and #5 on the inside, #5 came out a path causing #8 to steady and lose all chance for a better placing. #5 who finished second then was placed first after the first incident then was disqualified from first and place third behind #8. New order of finish 2-8-5-1-3-4-7-6. Stewards review Inquiry/Objections in the order of which they occur.
