Narrative:

Jockey Stephanie Sheroski, DOB: 03/19/1983, RCI ID: 636795, is Summarily Suspended pending her appearance before the Board of Stewards for refusing to submit to a urine test or blood test approved by the Commission. Miss Sheroski failed to comply with an order of the Stewards. A violation of D.T.R.C. Rules 18.5 All, 2.5.1.4, 21.3.1.6, 21.4 All, 3.3 All and 3.4 All.

Amendment A: November 10, 2023

A Stewards hearing was conducted November 6, 2023, in the matter of Jockey Stephanie Sheroski who refused to submit to a random drug test on September 16, 2021. Miss Sheroski provided the Stewards with a report on November 10, 2023, from Clinical Alcohol and Drug Assessment (New Directions from Des Moines Ia.) and a Negative Drug Test from Escreen in (Gainesville Florida). Stewards reviewed the documentation received by Stephanie Sheroski and determined:

This is Stephanie Sheroski's fourth lifetime substance abuse violation.

Pursuant to D.T.R.C. 21.9.4 For an individual's third violation, the individual shall be banned from participating in horse racing within the jurisdiction of the Delaware Thoroughbred Racing Commission. The individual may apply to the Commission to have the ban lifted after not less than five (5) years have elapsed since the last violation. The decision to lift or not to lift the ban is within the sole discretion of the Commission except that no individual is eligible to have a ban lifted without documentary evidence of satisfactory completion of an in-house substance abuse program approved by the Commission. Stephanie Sheroski is banned to participate in horse racing in the State of Delaware from September 16, 2021, through September 16, 2026.
