The winner #8 Desvio (Curtis) reserved in midpack for a mile, commenced a rally 4 wide to the stretch, was pushed out a path in mid-stretch, dug in to the wire to narrowly get up in time.

#3 Domingo (McCarthy) stumbled badly at the start unseating the rider.

#5 Triple Espresso (Castellano) pulled up on the first turn and was vanned off.
