Dear Governor Meyer and racing fans:

It is an honor to report on the activities of the Delaware Thoroughbred Racing Commission for 2025.

Delaware Park commenced its 88th season of live racing in 2025, with an initial schedule of 75 live racing days. During the meeting, four full race days were cancelled due to excessive heat or insufficient entries, and one partial race card was cancelled because of inclement weather. These lost race days were rescheduled during the meet, and the racing season was extended by two additional days at the end of the calendar to accommodate the make-up dates.

*Some highlights of the 2025 meet included the \$392,000 **Gr.3 Delaware Handicap**, a 1 1/8-mile event for fillies and mares was dominated by "Regaled" the four-year-old filly won by 6 ¼ lengths over a muddy track. "Regaled" was ridden by jockey Joseph Ramo and trained by D. Whitworth Beckman. DelCap Day featured 10 races for the day with a total handle of \$2,958,254.*

*The \$300,000 **Gr.3 Delaware Oaks** once again attracted competitive field of fillies. "Fondly" trained by H. Graham Motion and ridden by New York based jockey Irad Ortiz Jr, seized the early lead over a field of nine and drew off to win finishing three lengths over the favored runner-up "Margie's Intention".*

*The inaugural running of the \$200,000 **Delaware Derby** was also run on Delaware Oaks Day; a 1 1/16-mile event restricted to 3-year-olds drew a field of eight and was dominated by the colt "Admiral Dennis", ridden by jockey Luan Machado and trained by Brad Cox. Oaks and Derby Day featured 10 races for the day with a total handle of \$6,346,429.*

The Commission continued its participation in the voluntary agreement with the Horseracing Integrity & Safety Act (HISA) and Horseracing Integrity & Welfare Unit (HIWU) for the 2025 live racing meet. HISA was created to implement a national uniform set of integrity and safety rules to the industry. HIWU is the enforcement agency for Anti-Doping and Medication Control (ADMC).

Under the agreement the Commission no longer has authority over equine drug testing or investigations related to any ADMC violation. In addition, all revenues once previously paid to the commission from a violation of the ADMC rules or any rule violation included in HISA 2200-2293 series, are payable to HISA directly.

The information in this report will provide an overview of the various activities and programs that the Delaware Thoroughbred Racing Commission oversees. The Commission is committed to applying the highest standards in the regulation and oversight of this great industry.

All funding for the DTRC comes from the Appropriated Special Fund (ASF) derived from licensing fees and fines.

No general fund money is used in the operation of the Delaware Thoroughbred Racing Commission.

DELAWARE PARK SEASON OVERVIEW

For its 88th season, Delaware Park scheduled 75 live racing days, maintaining the same total as in 2024. Four days of racing were canceled due to lack of entries or weather-related incidents that rendered racing unsafe for all participants. These days were rescheduled throughout the remaining schedule and added at the end of the racing calendar. The live racing season concluded on October 18th.

In 2025 Delaware Park paid out a total of \$19,680,000.00 in purse money, this is a 14% increase from the 2024 meet (\$17,278,250.00).

In 2025, 185 horses were claimed at Delaware Park. Of the 185 claims, 168 claims were valid, an increase from 153 valid claims in 2024. The total amount spent on claimed horse for 2025 was \$1,921,500.00 The average claiming price rose slightly to \$11,437 compared to \$11,328, in 2024. As mandated by the Horse Racing Integrity Act (HISA) all claimed horses are required to report to a designated claim barn for one-hour post-race for commission veterinarian examination. Under this mandate, a total of 17 claims were declared void for failed post-race examinations and did not change ownership, this was a decrease from the previous year reported number of 23 voids.

Delaware Park reported an increase in racing activity for 2025, concluding the meet with 613 races and 4,345 horses starting. This is an improvement over 2024, which concluded with 603 races and 4232 horses participating. The average field size also rose slightly to 7.09 starters per race compared to 7.01 in 2024.

EQUINE FORENSIC DRUG TESTING

The Horseracing Integrity & Welfare Unit, also known as HIWU, is the independent agency that enforces the Horseracing Integrity and Safety Authority's (HISA) Anti-Doping and Medication Control (ADMC) Program. Equine drug testing in all forms is now under the direction and authority of HIWU. The DTRC collects blood and urine samples under the direction of HIWU and no longer has a role in investigating potential violations or prosecuting any alleged medication violations. HIWU has indicated it will make testing data public record during the first quarter of 2026 once their annual report is released.
