



2026 January to June Commercial Liming Materials Tonnage Submission Instructions

Please Read the Instructions *Before* Completing the 2026 January to June Tonnage

A Completed Tonnage Form per firm **must be** submitted, *even if No Sales are being reported*

Late Fee

On August 1, 2026 a late fee of \$10 or 10% of the total tonnage tax owed, whichever is greater, will be applied. The late fee will increase on the first of every month that the tonnage form is not submitted. A lien will be placed against future product registrations for the amount owed, including surcharges.

How to Complete the Tonnage Form by Section

Please use the fillable form feature and type the information onto the tonnage form per firm. **Do not combine firms onto one form.**

Company/Firm Information

Do not enter outside registrant information in this section.

- Exact information that is on the product label.
- If you do not use a **Registrant** (see definition below) please put all contact and mailing information in this section only.

Registrant Information

- Company/Person other than the company listed on the product label that is responsible for submitting registration
- **Proof of Registration will be mailed to the Registrant mailing address if this section is filled out.**

Product List

EACH product that was registered for July 1, 2025 - June 30, 2026 MUST be listed ONLY if you owe tonnage.

- Product name MUST match the product name on the registration form
- CaO%, MgO%, and Type of Lime: List if applicable
- County Code: **1** = Kent, **3** = New Castle, **5** = Sussex
- Form: **Bag, Bulk, Liquid**
- Use: **1** - Farm, **2** - Non-Farm, **3** - Golf, Athletic Field,
4 - Garden/Landscape, **5** - Potting/Planting Soil, **6** - Nursery/Greenhouse
- Total Tons: **Please convert pounds to tons. For example 500 LBS = 0.25 Tons**

Please use the fillable PDF feature and type in all needed Tonnage information.

If the instructions are not followed the tonnage submission may be denied and sent back and a hold placed on your 2026 Registration.
